The Board reviewed Policy 11: Staff Code of Conduct and Policy 12: Teaching Staff Reduction and determined that no changes were needed at this time. Policy 19: Conflict of Interest and Nepotism was brought forward to review and the following changes were made:

- employees can hold executive positions on school councils where they work, however, signing authority must lie with other members of the school council.
- it is recommended that family members not work in the same facility when one member is in a supervisory position, but if circumstance warrants, an individual assessment shall be made and approved by the Superintendent.
