TEACHER VOLUNTARY RETIREMENT PROGRAM 2018

Teachers:

The voluntary retirement program for teachers who are planning on retiring at the end of this school year is as follows: The program allows teachers to retire on January 31, 2018 and then be offered a temporary contract, from February 1, 2018 to the end of June, 2018. Pension would commence effective February 1, 2018. Beginning in February, 2018 and continuing until August, 2018, retired continuing teachers would receive their regular salary, plus their pension.

Information about the program:

- Teachers must be at least 55 years of age or older on January 31, 2018 and hold a continuing teaching contract;
- Teachers must submit their notice of retirement by December 15, 2017, with an effective date of January 31, 2018 to Mr. Chris Smeaton, Superintendent of Schools;
- Application for pension benefits is the responsibility of the individual teacher, and must be made to the Alberta Teachers' Retirement Fund by January 31, 2018 for pensions to commence on February 1, 2018. - Application forms for ASEBP early retirement benefits will be provided by our payroll department. To ensure that your application form is received by ASEBP in time to qualify for early retiree benefits, your completed application forms must be returned to payroll by January 8, 2018.
